<b>5.</b>	<b>VEHICLES ELIGIBLE TO PARTICIPATE</b>
	All vehicles must be in conformity with the Technical Regulations of the FIA E-Rally Regularity Cup.
<b>6.</b>	<b>GENERAL CONDITIONS</b>
<b>6.1.</b>	<p>The event will be organized in conformity with:</p> <ul style="list-style-type: none"> <li>• the FIA International Sporting Code and its appendices;</li> <li>• the Sporting Regulations of the FIA E-Rally Regularity Cup;</li> <li>• the applicable prescriptions stated in the National Sporting Regulations; and</li> <li>• the present Supplementary Regulations.</li> </ul> <p>The Organizing Committee will ensure that the event complies with all the rules and regulations stated above, and that the event has received all the required administrative authorizations.</p>
<b>6.2</b>	<p><b>Insurance</b></p> <p>The organiser provides a third party liability insurance whose taker is FPAK (Federação Portuguesa de Automobilismo e Karting) with the cover per accident limited to 48.560.000€ in corporal damage or 9.760.000€ in material damage.</p> <p>Competitors are reminded that only damage caused to third parties by the Organisers and the entered drivers is</p>

	<p>covered by the insurance policy taken by the Organisation. Injury to the drivers themselves or damage to participating cars is not covered by this insurance.</p> <p>In case of an accident, the competitor or his representative must notify the Clerk of the Course in writing as quickly as possible and within 24 hours. He must explain the circumstances under which the accident occurred, eventual causes and consequences. Likewise, he must mention the names and addresses of any witnesses. He must also mention the names and addresses of any eventual injured people.</p> <p>By submitting their entries, the competitors, drivers and car owners waive any claims or rights to pursue action for damages in connection with the event against the organiser.</p>

<b>8.</b>	<b>RUNNING OF THE EVENT</b>
<b>8.1.</b>	<b>Nature of the event</b>
	<p>The PORTUGAL ECO RALLY is an E-Rally Regularity event. Each competitor will collect penalty points from the "Regularity Stages" and from the road connecting the sections (Time Control penalties) in accordance with the present Supplementary Regulations and the Bulletins, which may be issued at a later stage.</p>
<b>8.2.</b>	<b>Start, Finish, Results</b>
<b>8.2.1.</b>	<p>The start signal for the event will be given in Jardins Palácio Marquês de Pombal, Rua do Aqueduto, Oeiras – Portugal – Saturday, 9 June 2018.</p> <p>The first car will start at 09:00 am</p> <p>During the overnight stay and after the finish the cars will remain in the Parc Fermé, which they will enter as soon as they finish a Leg.</p> <p>The starting sequence will follow the participation number and the cars will start at one-minute intervals.</p>
<b>8.2.2.</b>	<p>The first Leg will be constituted by 4 of Regularity Stages and 1 of regroupings, charging stops.</p> <p>The second Leg will be constituted by 5 of Regularity Stages and 1 of regroupings, charging stops.</p> <p>The distance covered will be 371,96 km (239,76 km first Leg – 132,20 kms second Leg) per each section / Leg and each Regularity Stage. A preliminary timetable must be included.</p>

<b>9.</b>	<b>Charging (BEV/PHEV)</b>
	<p>The organising committee will supply for recharging electric power:</p> <ul style="list-style-type: none"> <li>• Recharging points: Jardins da Adega do Marquês, Rua Aqueduto, Oeiras – 38°41'36.71"N 9°18'57.00"W</li> <li>• Voltage / Amperage supplied: 220/16</li> <li>• Type of sockets: CEE 321 / 031</li> </ul> <p><b>NOTE: The number of sockets in every recharging point as well as the energy supplied must be sufficient to connect all entry vehicles, plus 10% in case of malfunction of any of the sockets.</b></p>

	<p>The amount of the entry fee is fixed for each crew comprising two people (driver and co-driver, or driver and navigator):</p> <p>a) With the optional advertising proposed by the Organiser: 369 EUR  b) Without the optional advertising proposed by the Organiser: 615 EUR</p> <p>The Organizer will provide the participants with material and services as referred to in Art. 11 in the Sporting Regulations of the FIA E-Rally Regularity Cup.</p>
<b>11.1</b>	<b>Refund Entry Fee</b>
	<p>Entry fees will be refunded in full:</p> <ul style="list-style-type: none"> <li>- If the entry is not accepted.</li> <li>- If the event is cancelled.</li> </ul>
<b>11.2</b>	<b>Crew documents</b>
	<p>A crew comprises one driver and one co-driver, or one driver and one navigator. Both must be a holder of the following documents:</p> <ul style="list-style-type: none"> <li>✓ Driving licence according to the entered vehicles (not applicable for the navigators only)</li> <li>✓ Any grade of FIA licence, issued by their ASN, or</li> <li>✓ An FIA licence, grade D (or equivalent), obtained for the event, and valid for its duration, which has been issued by their ASN or by the organizer's ASN (with the written permission of the competitor's ASN) and handed over to the participants at the latest during the administrative checks. It will be subject to the payment of a fee of 100 EUR.</li> <li>✓ Vehicle document permitting its free circulation on public roads.</li> <li>✓ Should it be applicable, a vehicle document required in the Technical Regulations of the FIA E-Rally Regularity Cup.</li> </ul> <p>Vehicle valid insurance certificate in accordance with the traffic Code.</p>
<b>11.3.</b>	<b>Entry Form</b>
	Any person, or legal entity, wishing to participate to the event must submit to the Event Secretariat, a properly filled-in and signed entry form (see Appendix 1), together with all other requested documents, photos, etc. before friday, 1 june 2018.
<b>11.4.</b>	<p>The field for participation is limited to a total of 50 entries.  All entry forms received after the above number of vehicles has been accepted will be entered on a reserve list.</p>
<b>11.5.</b>	The minimum number of entered cars is: 10 cars.
